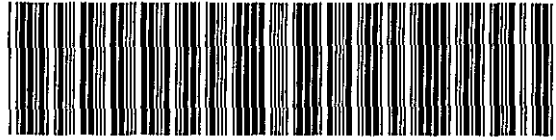



THE UNDERSIGNED, Alex Hull, President of THE CENTRAL FLORIDA CHURCH, INC., a Florida not-for-profit corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation:

ARTICLE FIRST: The name of the Corporation is THE CENTRAL FLORIDA CHURCH, INC.

ARTICLE SECOND: The Amendment to the Articles of Incorporation of the Corporation effected by these Articles of Amendment is that ARTICLE 1 of the current Articles of Incorporation is amended to provide as follows:


ARTICLE 1 - NAME

The name of the corporation shall be ORLANDO CHURCH OF CHRIST, INC.

ARTICLE THIRD: There are currently no members of the Corporation to vote on approval of the amendment to the Articles of Incorporation of the Corporation reflected in ARTICLE SECOND hereof, and, therefore, it was unanimously approved by the Board of Trustees on February 2, 2004.

IN WITNESS WHEREOF, the undersigned, Alex Hull, President of the Corporation, has hereunto set his hand this 2 day of February, 2004.




